Moreover, through our networking and conferencing, we hope to foster optional celibacy within the Latin Rite Catholic priesthood; to study the 'mysterious' model of marriage as applied to Christ and the Church; to involve resigned priests more and more in the work of the Church; to evidence the compatibility of marriage and the priesthood; and to affirm the authentic charism of celibacy as an option in ministry.

ynamic Work of the Conference

The centerpiece of the First National Conference on a Married Priesthood will be the conclusions reached in small groups workshops. Three sessions of workshops on the DIALOGUE TOPICS will address the same ten topics on Friday, June 17th. The workshops, led by teams of three co-leaders, will guide each of the ten small group workshops to:
• interpret the topic;

- · define problems they foresee in such an interpretation;
- · evaluate possible solutions;
- · outline the material covered and draw conclusions;
- complete a position paper on the topic, suggesting resolutions.

All are encouraged to attend the workshops of their choice during the

Corps of Reserve Priests United for Service Resolutions June 19, 1988

Be it Resolved: Since mandatory celibacy is starving the Catholic Community of sufficient ordained priests, we encourage and affirm:

- 1. That the Church in the United States initiate a widespread program of identification and reconciliation with inactive priests, and that an expedited program of pastoral research and needs assessment be undertaken in order to identify areas of priestly collaboration and service for these brothers in Christ.
- 2. That in the light of the fact that 43% of the parishes worldwide and 10% currently in the U.S. are pastorless, while at the same time there are over 5,000 resigned and married priests in the U.S. prepared to render sacramental service, CORPUS urges Church leaders to affirm publicly the perduring nature of the priesthood and its powers, which always can be validly expressed and exercised especially in times of critical shortage.
- 3. That women's presence be more explicit in CORPUS.
- 4. That CORPUS be helpful in expressing an enriched theology of marriage.
- 5. That CORPUS be a model in respecting women by promulgating women's concerns and perspective in the continuing dialogue for married priest's' ministry.
- 6. That there be more financial responsibility and accountability on the part of CORPUS' members.
- 7. That CORPUS help facilitate reconciliation between the institutional church and its wounded priests and their wives.
- 8. That CORPUS model equality between men and women in marriage and ministry.
- 9. That CORPUS make available wider access to its resources including the wealth of its lived experience by:
 - -Telling the stories of its members' spiritual journey
 - -Developing spiritual communities
 - -Encouraging one another to do ministry as married priests
 - -Relating in a caring way to celibate priests and religious especially by maintaining friendships
 - -Funding the development of a theology of sexuality and marriage
- 10. That CORPUS consider the establishment of a broader lay organization to enlist the support of the larger church.
- 11. That CORPUS approach the Priestly Life and Ministry Committee of the NCCB to establish a pastoral provision for the good of the faithful to utilize willing, resigned in the presbyteral service of the church similar perhaps to the pastoral provision used for the convert clergy.
- 12. That CORPUS area representatives prepare a list of reigned priests available in the local dioceses for presbyteral service, especially in emergencies.



- 13. That married priests in active part-time or full-time ministry deserve adequate financial support, and the Catholic community has both the will and the resources to provide that funding. Another options for renewed service are the self-supporting married priests.
- 14. That the dioceses and orders provide for transitional services to their former clergy: counseling, out-placement, health insurance, pension, job listing, and small business loans. Further, all punitive exclusion from employment or service in church is abolished, including all liturgy, social action, and education that is open to lay people.
- 15. In the light of the wisdom of Jesus who chose both married and unmarried person to be his disciples and collaborators, and reflecting on the honored place of a married priesthood through many centuries of the church's history, and the reception of married Episcopal priests into the Latin Rite, CORPUS proclaims that a multifaceted expression of priesthood, including a married and unmarried priesthood, is fully reflective of the will of Christ, is in the best interest of the People of God, and will enhance the authentic life and order of the church.
- 16. In the light the following biblical truth:
 - -That women and men are created in the very image of God;
 - -That Mary's fiat to the Spirit bore and nurtured the body and blood of Jesus
 - -That Jesus said, "My mother and brothers and sisters are those who hear the word of God and keep it."
 - -That women proclaimed the resurrection to the apostles
- 17. And in the light of the sacramental truth that in virtue of baptism all Christians male and female are called to witness their faith...
 - -The exclusion of women from the priesthood on the basis of gender alone is contrary to nature and to the Spirit of Christ.
 - -CORPUS, therefore, affirms the right and aspiration of women to full participation in all ministries of the church and asserts solidarity with those who are moving to open these ministries to women.
- 18. Effective sharing of ministry between celibate and married priests requires clear and open communication between married priests, celibate priests and the hierarchy. CORPUS can be seen as the conduit for the sharing of information and the promoting of cooperative ministry. As a first step CORPUS encourages the U.S bishops to recognize the service and affirm the personhood of men and women, priests and religious whose choices involve a departure from canonical ministry.
- 19. CORPUS urges the founding and proliferation of small faith communities as providing an ideal setting for married priests to minister to the faithful. Such ministry recognizes and calls forth the priesthood of the laity which they share by reason of their baptism. Because of their familial nature these small faith communities also provide a nurturing environment for our young people while the example of the married priests ministering within them speaks to their hunger for a more authentic priesthood.
- 20. That the bishops and major superiors within the United States urge the Pope to recognize the mature decision made by thousands of priests and acknowledge their full and dignified status within the church, including all canonical requirement and benefits, even if these have not been sought or denied.



The Numbers Game

We do not want to get involved in a numbers game with anyone so we had better clarify our statistics. Originally we thought that if it could be established that at least one hundred resigned priests were willing and able to resume service to the official Church we would have established that "a significant number" would have established that a significant number were interested -- thus providing a documented res-ponse to those who had publicly stated, "The married/ resigned priests are no longer interested in serving the Church."

As a matter of fact, by the end of 1975, 56 married/resigned priests had subscribed to the CORFUS statement -- thus indicating willingness to resume active priestly service in the official Church. This 563 came from a list of 1400 names and addresses of married/resigned culled by CORFUS from various sources. Accurate lists of married/resigned priests are very difficult to obtain; there is hardly a more mobile

segment of the U.S. population.

Of the 1400 invited to subscribe to the CORPUS statement, 563 responded in the affirmative - better than one-third. Therefore, we argue that at least one-third of the married/resigned priests are ready to be reactivated.

How many U.S. priests have resigned ? now many U.S. priests have resigned? This is very difficult to determine. Sociologist Richard Schoenherr (who worked on the Bishops' NORC sociological study of the priesthood) has tried to maintain a statistical record of U.S. priests and he claims about ten thousand have resigned. We are inclined to accept his figure. If it is a little high, chances are that by the end of the year it will be found to be a little low - so we accept it as a good working figure.

Further, historian Terry Dosh accepts the ten thousand figure and notes that of these 90% are less than 45 years old and thus he concludes that one-third of all U.S. priests in this age group are now married.

Using the ten thousand figure and projecting our more than one-third response we conservatively project "more than three thousand" married/resigned American priests are available for Church service.

So goes the numbers game !!!!

Please continue to send us names and addresses so that we may reach as many resigned/married priests as possible. However, we do feel the emphasis must shift from collecting names to more direct action - such as establishing models of resigned/married priests actually involved in Church work.

PERMANENT DEACONS ????

A recent news item reports that "requests of A recent news item reports that "requests of laicized priests who want to be permanent deacons has increased in the last several months but that the Vatican told the committee "that such requests ought not be taken seriously!". We know of no priests who want to be permanent deacons - we are permanent priests -but there are many priests (resigned and married) who are willing to serve in the diaconal role(as we have done many times in the past at solemm Mass etc.) - especially in the traditional service aspects of that order. More on this in future newsletters.

MERRY CHRISTMAS !

As a Christmas gift to each of our nation's bishops CORPUS mailed a copy of Chicago Studies/NFPC Reconciliation: Pastoral Priorities 1975. This bishops responded with notes of thanks.

Two of the nine articles in the above book pertain to resigned priests. These have been reprinted and are being distributed as widely as possible.

UPDATE OF CORPUS STATEMENT

The CORPUS statement has been revised somewhat to keep up with the new year and the theme of freedom and justice. The reservist model has been de-militarized and references to service as a deacon have been eliminated to avoid confusion. Finally, anonymity has been eliminated and emphasis directed to action on the local level. Copies of the revised statement are enclosed. Your reactions are vital.

A WORD OF THANKS (sent for your information.) On the letterhead of the Presbytery of the Archdiocese of St. Paul and Minneapolis, and over the signatures of the chairman of the senate, and the names of all the senators, the following letter was sent on May 20. 1974, to the resigned priests of that Archdiocese.

On April 25 the Presbytery celebrated the seventh anniversary of the formation of the Senate of Priests. Archbishop Bynne attended, a guest speaker addressed us on the subject of "Reconciliation and the Presbytery in the Early Church", and a special recognition award was presented to Gerry Keefe.

This event presents us with the opportunity to

express to you and to many others who have left the active ministry our thanks for the many years of good service you provided the Archdiocese while you were among us.

We have a lot in common. We studied together in the seminary, we were together at ordination, and we shared the same work in the Archdiocese. We want to express to you our sincere gratitude not only for all your contributions to the Archdiocese but also to us personally.

we deeply regret the factors which separate us we know that many of you have suffered a lot in reaching the decision that eventually lead to your separation from us.

With this note and sincere expression of thanks for your work and presence among us go our warm wishes for you personally, your present work and family obligations you may have assumed.

It started as outreach. After drafting a letter inviting resigned priests to sign-on to returning as long as their wives and families were recognized and respected, the follow-up became the CORPUS Newsletter.

It included updates on the early energies of CORPUS as well as happenings in the church which offered a glimmer of hope.

In our households, the CORPUS Newsletter became a beacon of hope. It touched us and began to heal the pain of rejection and separation. It offered a gospel miracle.

We remain grateful for the initial coordinators efforts to keep the light shining as CORPUS grew into a national movement. It became obvious as we entered the decades of the '80's that a more formal and regular notice was essential.

Our founders turned to Terry (and Millie Dosh). Stepped in theology, experienced in community

building and committed to the vision of CORPUS, Terry began the groundwork of coalizing local energies into wider communities. Meetings were held and eventually an "area rep" system was in place.

Throughout it all, CORPUS REPORTS played an absolutely essential role.

After our first national conference, CORPUS leadership transitioned and expanded. Original founders, Frank Bonnike and Frank McGrath, along with Terry Dosh, welcomed ten area reps to meeting and continue to strategize for the acceptance of a married priesthood.

Shortly afterwards, the Board hired Skip Sikora to become a National Coordinator and Editor of CORPUS REPORTS. His professional background brought a new look and new outreach. Years later, enter David Gawlik, magician par excellence! His background in publishing put CORPUS REPORTS on the map! After ten years, he handed off the task to Linda and Ralph Pinto. *

We are eternally grateful to each editor but especially to our members who filled the pages with cutting edge theology, ecclesiology, contemporary movement news and members' happenings. Your wit and wisdom made us shine!





The biggest blessings to come to me through CORPUS are fellowship with other married Roman Catholic priests and their spouses, our shared conviction that God gave us the call to service both in priesthood and in marriage, and the affirmation that we are a prophetic voice within the Church. I am grateful that as a priest my life and ministry are better because I am married. better because I am married.

CORPUS has been a Beacon for me ever since it was started. Having made my decision and moved from the celibate Priesthood in 1968, I was thrilled to follow Anthony Padovano and the team that organized this movement,

It said the things I also professed. The theology so well expressed by Anthony was so logical and so factual, it made our move so reassuring and hopeful. It clearly was inspired by the Holy Spirit.

And therefore, tho so many of us will have passed on before any real change in the system, we know and are full of Hope that the SPIRIT will continue to guide the Church to a more Human and Renewed Priesthood for the People of God.

Thank you to you and the many others with you who have produced "CORPUS REPORTS", they were filled with many various and important subjects, so useful and supportive of our goals. We will miss them. But we will continue to follow the SPIRIT, as IT guides us and we will continue to pray for one another. Best wishes,

As I read of the probable timely end some thoughts:

Dates to remember -

CORPUS was conceived in November 1973 at a dinner hosted by Barry Rankin (cf obit) at the Beef Steak Inn on Sheridan Road Chicago by Jim Wilbur -ordained 56..,Bill Nemmers 57 and myself 57.(and wives) Speaker at that dinner was Frank Bonnike who none of the three of us had ever met before.

Since we were unknown.and Bonnike was well connected we thought of inviting him to join us. Jim Wilbur contacted Bonnike and we met for the first time in Spring of 1974 at the newly married Bonnike home and CORPUS was born. Frank with a military background came up with the "reserve" name and idea.

Thus was CORPUS born. Symbolically we picked Dec.24,1974 when the Holy door of the Holy Year of Reconciliation began as our birthday. What could be more appropriate than the church reconcile with her married priests.

The most important person in the early days was Jim Wilbur, who at that time was editor of the J. S. Paluch Missalette and had the resources (mailing lists etc)of the Paluch organization. HOWEVER since Jim had to see Cardinal Cody to publish every month his name could not be associated with CORPUS even though he did most of the contacts. Thus the name of Jim Wilbur did not appear on any CORPUS material as long as he was with J.S. Paluch.

Another important person was Joe Marto who joined us later and helped to run the first gathering of CORPUS representatives- a list gathered together by Bill Nemmers. It was at this meeting that we met Terry Dosh.

Recollection of CORPUS by Elaine McGillicuddy

My name is Elaine McGillicuddy, and I live in Portland, Maine. I was an Ursuline nun, and my husband Francis (who died 13 years ago) was a diocesan priest. Each of us had been assigned to Waterville, Maine, in September 1968, Father McGillicuddy as assistant pastor at Sacred Heart Church, and I, Sister Maureen (the name I had chosen as my religious name) as an eighth-grade teacher in the school he would oversee.

Father McGillicuddy's duties and mine overlapped from the beginning, bringing us into frequent contact. Eventually, because we fell in love, I left the convent. And then, after Francis received a "dispensation" from Rome, he left the priest- hood. After we were married in 1972, we bought a house and in Portland, Maine.

I can't remember how or when I heard about CORPUS, which stands for **Core of Reserved Priests United for Service.** And when I did (to use a cliché) - it was a "God-send!"

After reading what Linda Pinto wrote about CORPUS REPORTS' ending with their autumn issue Linda emailed me. She asked if I would be willing to write a Recollection of CORPUS. I responded: "Yes I will, Linda, because a project like this will bring back special memories. This project certainly has done that.

During a weekend CORPUS conference in Washington State, Francis and I met Sylvia and Allan Moore. After seeing them at other CORPUS conferences, we became good friends.

After Allan died in July this year, I telephoned Sylvia two or three times.

Then, when a conference was held in Wisconsin, Francis and I met David Gawlik. I remember that when we stepped off the plane, David greeted us by saying something funny, and we all laughed.

After Francis died on January 3, 2010, some years later, I felt drawn to write. After I left the convent, my first job was teaching English composition at Thornton Academy in Saco, Maine (not far from Portland). That experience seemed to me a kind of preparation to be a writer.

Over a period of three years, from 2012 to 2015, I wrote three books: SING TO ME, AND I WILL HEAR YOU THE POEMS; SING TO ME, AND I WILL HEAR YOU A LOVE STORY, and SING TO ME AND I WILL HEAR YOU NEW POEMS.

I can't remember how I learned that David owned a book printing company called "Caritas Communications." In any case, after I wrote the first book, I called David and asked if he would publish my book. When he readily agreed, I was relieved and very grateful.

Four years later, in 2019, I wrote another book: *ANCESTORS – A WIDOW REFLECTS*.

TO COMMUNE WITH THE

By this time, David no longer printed books. self-publish this book. Thank you, David!

But he helped me at every step to



Francis and I also made friends with Marie and Stu O'Brien who live in Massachusetts. We visited them a few times. Then when Marie died in April 2005, we drove from Portland to Raynham, Massachusetts, to be present for her funeral. I still keep in contact with Stu.

Theresa and Anthony Padovano are the last couples with whom Francis and I made friends, thanks to CORPUS Conferences. I remember that we not only visited them where they lived in New Jersey, but years later, Theresa came to our home and stayed overnight. The next day she joined us in our car and drove to Boston. On Sunday, she joined

Anthony when we attended mass at St. Cecelia's parish.

Francis and I appreciated Father John's sermons so much that I attend mass online when the weather is not feasible here in Portland.

When I told Linda that writing my "Recollection of CORPUS would "surely bring back wonderful memories," it certainly has. This project did more than that. It reconnected me with excellent friends.

Now I'm in contact with Sylvia Moore, David Gawlik, Theresa Padovano, and Stu O'Brien, four members of CORPUS! Praise the Lord!



What a wonderful finale you are preparing to 50 years (1974-2024) of CORPUS!

I left active ministry in 1970, trusting that God would provide and provide God did, in spades, but with vital CORPUS assistance, both moral and corporal.

The contacts and assistance provided by membership in CORPUS helped me to "build a life I could live with"!

Having known nothing but seminary life and ordained existence for 40 years of my life, I came to the realization, thanks to Vatican 2, that such an enforced life of celibacy was not to be for me for the rest of my life.

Now, at the age of 91, I look back with gratitude to CORPUS for the leadership and guidance provided me at the pivotal moment of my life, the year I asked for and received laicization.

My life since that event has been very fulfilling (married to my wonderful wife, Eileen; two daughters, 5 granddaughters and two great grandchildren), a professional career as an Ex. Dir. of Regional Mental Health Centers in Mississippi and a normal personal private life.

Thank you, CORPUS, for helping me to "build a life I could live with"!



COMPANIONS ON A JOURNEY

Sisters and Brothers, Companions on a Journey, Good Morning. We feel so blessed to be part of such a graced gathering. It's really a Communion of Saints - at least saints-in-the-making.

According to Andy Warhol, everyone is famous for at least 15 minutes of their lives. These are probably our 15. We plan to use a little less so we have some time left. Our readings this morning focused on Christ's call to us, our recognition of that call, and our oneness in Him. For a few moments, we who are Companions on a Journey direct our hearts to God's message and our lives.

How do you feel about the times in which we live? Happy, sad, hopeful, depressed, content, angry? Although obstacles to a married priesthood are present, we believe the opportunities are far greater. After all, the Spirit is alive and well, and we are an Easter People.

This past year, our six-year-son, Phillip, came home from our Parish School of Religion with a picture he had drawn. It was a priest celebrating Mass in a church. I said, "Phil, that looks great," and he said, "It should, Dad, you're the priest." Out of the mouths of babes... As I said, the Spirit lives.

We suggest that we are Companions on a Journey in at least four ways: with God, with clerical priests, with the laity, and with one another.

We are Companions with God

Being married to a husband is more significant than being married to a priest. After all, Scripture is emphatic in saying that, "In the beginning, God made them male and female." We leave our parents, cling to our spouse and we become one body. Only later did God give us priests - and much later than that, the Church gave us celibate priests. By God's call, we enflesh the deep and lasting love He has for all of us, and we become a sacrament, a living sign, that God is always with us. In addition, the second reading from Paul's Letter to the Galatians makes it clear that our faith and baptism call us to a unity with Christ so rich that we inherit all that God has promised to His people. And haven't we experienced that this weekend?

All too often, fear and frustration have paralyzed our efforts. Let it be clear that this is no longer true. We have come to claim our birthright and our ministry. Yes, the ministry is ours. Phil's and mine, and yours as well. We believe the Church is going to receive a real bargain - two for the price of one. What if those who had gone before us had taken these bold steps? Now it is our mission. Yes, indeed, companions on a journey with God.

We are Companions with Clerical Priests

Clerical priests need the depth of our love, the richness of our experience, the honesty necessitated by living so closely with a spouse, and the awesome blessing of giving and nurturing human life. Last year, the Committee on Priestly Life and Ministry of the National Council of Catholic Bishops prepared a reflection on the morale of priests. The bishops candidly admitted a serious problem with priestly morale. As the shortage of priests increases, a profound weariness overtakes those who are called to do double duty. Frustration builds because of the conflict between an increasingly legalistic hierarchical structure and a people in need of a Church with creative leadership and warm understanding. Even more, obvious solutions to this clergy shortage cannot even be discussed.





This is where we come in. Just think, in the United States alone, there are 18,000 marriages just like yours and ours. Our insights into marriage and family life, and our ability to cope with everyday life in a world of complex change are invaluable. If those in Church leadership positions wish to be traditional in the best sense of the word, why not go all the way back - back to the very beginning - to a married priesthood. I sincerely believe I am a far better priest now than I have ever been. Linda didn't "steal" me from the Church. Rather, she has enabled me to minister with greater honesty and integrity. Many priests and their wives are ready to do the same.

In regard to health and longevity, studies have clearly shown that we live longer than priests who remain unmarried, and our mental health is better. I know that I am encouraged and emboldened when I have Linda by my side. Perhaps the Church isn't ready for us. But the Church does need us - our holy impatience with imposed legalism, and our fierce loyalty to Christ. In fact, I welcome the opportunity of taking a loyalty oath to Christ. Also, the Church needs our gift of hope after so many of us have been pushed and shoved and sometimes crushed by an often insensitive institutional Church. To our brothers in the clerical ministry, we say that married priest couples will enhance your ministry. With you, we are companions on a journey.

We are Companions with the Laity

We are companions because we share baptism, confirmation and marriage with you, along with a unique understanding of the life you live.

We, too, struggle to raise our children the right way. We understand the fear which all too often exists because of a lack of job security. As a clerical priest, Phil's job was always guaranteed. How about trying to stretch that paycheck to cover just one more bill? What about our beloved Church which sometimes seems distant rather than embracing, reliant on power rather than service, rigid legalism rather than living tradition, and fear rather than love. Believe me, we understand.

I believe we have all seen the familiar sight of geese flying in a V formation. Recently, our bishop told our parish congregation that he had researched this phenomenon. The V enables each bird to benefit from the draft of the one in front, making it easier to fly. In marriage and as the people of God, we are meant to be the wind beneath each other's wings. And what about that head bird out in front? No worry, that's the Holy Spirit. No matter how turbulent or long the journey, the Spirit will lead us where we need to go.

The love Phil and I share as husband and wife becomes the love we share as father and mother. We, too, love children, but how many, and how do we determine the size of our family? Important questions often demand agonizing choices. We understand because we walk that proverbial mile in your shoes.

As married couples, we bring together in one graced union priesthood and laity and, if our marriage is what God calls it to be, the distinction between priesthood and laity is completely overshadowed by a love which seeks to serve rather than be served. With you, we believe the people are the Church and the Church needs us to help it grow. We may not always agree on how things should be done, but we will do all we can to get it done. Together with you, the laity, the lifeblood of the Church, we are companions on a journey.

We are Companions with One Another

As wife and husband, we are companions on a journey - with one another. In today's Gospel, Jesus asks His apostles, "Who do you say that I am?" Each of us has been asked this same question by Jesus. And we answered as Peter did - You are the Messiah. That answer has brought us to where we are today. As Christ promised, that answer has called us to walk in His very footsteps. Every couple here embodies a singular love affair with Jesus. Each of us has recognized the Christ in our spouse and spoken a promise of fidelity and love before God which will last forever.



I literally owe my life to Linda. Shortly after our marriage in 1982, I felt chest pains with increasing regularity, but there was no way I was going to a doctor. At this point, Linda made her presence felt. By the way, she gives all the credit to the guidance of the Holy Spirit. All preliminary tests proved to be negative. However, because of her strong insistence, my doctor ordered a cardiac catheterization which indicated extensive coronary blockages. Again, she got behind and pushed. Seven years later, without surgery, but with our own diet, exercise regimen, lifestyle changes and most importantly, prayer, my angina is completely gone, there are 30 less pounds of me, and my cardiologist is both pleased and amazed. Thank you, Linda! Thank you, Lord!

Some say kids keep you young and others say they make you old. We subscribe to the first theory. They certainly make us laugh! On Father's Day, while I was putting Joshua, our two-year-old, to bed for the night, he looked up at me with the cutest sly smile and said, "Dad, Happy Mother's Day." I smiled at the humor, and then it occurred to me that God is both "Abba" and "Imma," our Dad and our Mom. Without realizing it, the little guy had spoken a profound truth.

The married priesthood is here to stay because we are here to stay. We have been called by God who has plans for us - women and men. As Jeremiah said, "Plans for our welfare - not for woe." Each of our marriages is a sign that priesthood and marriage can be effectively combined in a union which brings a blessing to both marriage and the Church.

CORPUS and this conference state clearly to those in the Church who have ears to hear and eyes to see that we are here to serve. We want to serve. And we have a God-given right to serve. Christ, Himself, chose those who were married to be apostles and marriage is a beautiful sacrament. We have shared the Word of God in our readings and we now prepare to break the bread and share the wine of the Eucharist. In the beautiful words of the song by Carey Landry, "We are no longer strangers to each other, for we are companions on the journey." May the power of love and determination so evident in this Liturgy embolden us to take the next steps of our journey together.

We believe in the married priesthood because we believe in the love of our God. We journey with confidence because our ever-present companion is Jesus. We are His eyes. We are His hands. We are His feet.



I may not get to see my vision of an inclusive church in my lifetime. But, I know what it can look like, because I have seen it in the CORPUS community.





Tom McMahon .I'm 94 now, just having a pace maker implanted living with a 91 year old friend after my wife Elaine died three years ago; hence the e address Kjelstrom.dorothy@comcast.com

I see where you are gathering material for a final publication and if this is so I wonder what I might offer to recall past history, such as the convention in San Jose some thirty five+ years ago. I did write for *Catholica* in Australia for 12 years weekly until the blog collapsed when Brian Coyne had a nervous breakdown.

I still write,particularly about church history. I have traced the role of bishop back into before the common era, originally a roman tax collector and priest his agent., 300 BCE. I write a Tuesday Memo to about 120 weekly, old friends. (Tom, ordained 1954 for San Francisco, quietly married 1968, exiled from RC ministry in 1980 by AB John Quinn, pastoral educator of Community of Jesus our Brother which still exists today, except most Members have died, widowed in 2021, grandfather of five with oldest 18 now at Georga Tech.... how time has flown).

I have many memories and thoughts about CORPUS through my many years of membership from seventies. A close married priest friend first mentioned CORPUS after I transitioned in 1972. Service has always been at the heart and core of CORPUS. Listed below (alphabetically) was our outreach.

Catholic Organizations for Renewal (COR)

Catholic Organizations for Renewal (COR) is a coalition of Catholic groups inspired by Vatican II to further reform and renew the Roman Catholic Church, to bring about a world of justice and peace and to reflect the sacredness of al creation. Membership is open to any group whose constituency is primarily Catholic, and whose mission includes working to change unjust structures and practices in the Roman Catholic Church, as expressed in the foundational documents: The 1990 "Call To Reform" statement and the 1997 "We Are Church" Referendum. COR regularly schedules public events to highlight its work. Anthony T. Padovano and Linda Pinto served as CORPUS representatives.

Community of John XXIII

Recognized as religious community of the Ecumenical Catholic Communion, the Community of John XXIII gathered members in prayer, reflection and commitments to Relatedness, Justice Making and Mutual Collaboration. We participated in a program os study, prayer and reflection with an emphasis on transformation as well as information. Mary and Dick Scaine were facilitators.



CORPUS Ambassador (International)

CORPUS was an instrumental member of the International Federation for a Married Catholic Priesthood. This consortium of over 30 countries met on a regular basis to strategize and advocate for reform in the church. CORPUS was also a member of We Are Church: International. This effort was birthed in the 1990's as a signature campaign to gain international recognition and support for a reformed priestly ministry. Anthony T. Padovano served as our Ambassador. He was later succeeded by William Manseau.

CORPUS Ambassador (Mexico and Latin America)

It became clear that reform movements in Mexico, Central and Latin America were growing. Bob Walden was appointed as our Ambassador for these efforts

CORPUS Job Transition Services

Marty Hegarty and George Spellman had transitioned from active canonical priesthood to corporate America. They both realized how challenging it was to find adequate employment for men who were steeped in philosophy and theology. WOERC was established to assist priest in their new journey matching skills, talents and experience with available employment. Russ Ditzel helped continue this effort through CORPUS.

Database

As CORPUS began to grow through leaps and bounds, it became necessary to develop an adequate database for effective communication. As we entered the internet era, many talented "techies" came to our rescue. We remain grateful to Kirby Brown, Len Roach, Andy Kukec and Dan Neesley. And, as always, David Gawlik was always a constant (and magical) presence!



National Catholic Ministries Alliance

The National Catholic Ministries Alliance (NCMA) is committed to enable and nurture inclusive Roman Catholic ministries of women and men, women priests and married priests, committed to the work of Vatican II reform and renewal. This partnership and collaboration of organizations whose principle focus in the reform of the presbyteral ministry (CORPUS, Federation of Christian Ministries (Roman Catholic Faith Community Council), Roman Catholic WomenPriests and Women's Ordination Conference) originated in conversations in which was fondly called "ministry row". Each organization sponsored a booth at the annual Call To Action conference and a consensus grew to further our missions in the Alliance. William Manseau was the principle coordinator for CORPUS.



Pension Advocacy Campaign

The CORPUS Pensions' Advocacy Campaign was initiated in 2012 by a resigned priest of the Archdiocese of Boston, Paul McGreevy who was also a civil lawyer on behalf of a seminary classmate who was denied a pension by the Archdiocese after 25 years of service. He contacted the CORPUS Board of assistance and William Manseau, a Board member and member of the Boston Archdiocese married clergy, took on the project. He found assistance from a former parishioner, Dr. Richard Young, who chaired a Jewish community foundation named Trinitas which agreed to provide some seed money for the advocacy effort by The Emmaus Institute, Inc. which Manseau directed. The Institute determined that the issue has been thoroughly litigated. The courts have refused to intervene, seeing the matter as a First Amendment issue as the free practice of religion. Accordingly the CORPUS Pensions Advocacy Campaign has had to rely on grass roots work with local dioceses. Approximately one third of diocesan jurisdictions have implemented pensions for resigned priests. As a participant in this campaign I noted that this justice issue was contemporary with the Clergy Sex Abuse recognition explosion with the dioceses having to give their attention to the financial aspect of these court cases. A fuller report on this history is to be found on the CORPUS.org website which lists the participating dioceses.

That weekend was a highlight in my life and the beginning of a spiritual journey for which I am grateful to God.


The courtship continues even with one foot in the grave . I am appreciative for the support and cooperation through 30+ years of service to Jesus' "boys" and their families through the collaboration with CITI Ministries/Society of Christ's Priesthood, founded soon after that first CORPUS meeting. Del Smolinski's research project of 21 Canon Laws allowed us to respond through the free referral service "Rent A Priest" to requests from a spiritually needing public, without hierarchical interference. Even Louvain University produced a thesis legitimizing the ministry of CITI's free referra; service "Rent A Priest."

Thank you especially for the research platform you have provided through CORPUS REPORTS during these last few years. The cobweb of Roman Catholic clergy sexual abuse and mandatory celibacy slowly unwinds.

Except for my late husband Dick, married priests are the love of my life. They are my Church. I will never say goodbye because you will always be in my heart and soul.

We reprint the Eulogy given by his eldest son, Mark. We also reprint a tribute to him in Conscience Magazine, the periodical of Catholics for Choice.


Eulogy for Anthony T. Padovano

How do you honor a man that was so much to so many? To focus on his essence without remembering the complete would miss the grandeur of a life well lived. I will try to describe and honor the man who gave us so much. To many he was our teacher, our friend, maybe a colleague, our pastor, or family. To me he is dad.

Born September 18th, 1934 in Harrison, NJ to Thomas and Mary Padovano he had one sister, Rose Marie. From very humble beginnings he quickly discovered is lifelong love for learning, baseball, Italian food- especially desserts- and family. From an early age, he immediately rose to the head of his class, always reading, writing and challenging himself academically. I would say he was without hesitation, the most intelligent man I have ever known.

His great intellect and ever-present personal discipline would allow him to pursue and achieve a career of his choice. He once told me he struggled to decide between becoming a journalist because of his love of writing or joining the Navy because of his love of seeing the world and adventure. All of this before a profound celling to the

the world and adventure. All of this before a profound calling to the priesthood when he was 14 years old. This would become the defining moment of his life. From this point forward, he poured his talents and great intellect into his love of God and the Catholic Church.



To say he excelled would be a great understatement: he thrived! To quote Ecclesiastes: "Whatever your hand finds to do, do it with all of your might" – he lived this. In reading about his life and accomplishments, I lost track of how many Magna Cum Laude's he graduated with. I discovered he never wasn't magna cum laude: this includes seminary, all university work, including the Gregorian University in Rome. Doctorate in Theology and Doctorate in Literature. He wasn't just a great student, he was an academic titan-unrivaled!

He then used this knowledge from his studies and began teaching, another great love of his life making what he learned accessible to us mere mortals! As professor, and Roman Catholic Priest he again rose to the top of his calling, quickly becoming a highly sought after lecturer and scholar on the national and international circuit. He was a great teacher-again without equal. He wanted to convey his love of God and love of learning to others, and he did this so well.

This then led to the next part of his life, when he met my mother. His teaching requests brought him to Houston, TX. From the moment they met, he said he knew immediately this was the great love of his life. As they got to know each other, his great love for her never faltered, it grew exponentially. He once told her early on "you may find someone who loves you better, but you will never find another who loves you more".

Dad now found himself at a crossroad: His love for the priesthood and love for Theresa collided and a choice had to be made: give up the love of the priesthood- his focal point of his life's work and marry Theresa? Or save his life's work but lose Theresa? A gut-wrenching decision for most, but he

knew that his love for her surpassed all and everything he worked for. He would love and let the chips fall where they may. He chose her always, and he chose her forever.

He became husband, father, grandfather- but always a teacher, writer, and constantly pursuing the divine. He was one of the founding faculty of Ramapo College since 1971, where he became Distinguished Professor of literature and philosophy for 45 years. He never stopped reading, writing, teaching and loving my mom and all of his family.

All of this leads me to ask, how do I best remember him? To honor him, I've decided to write an open letter to him:

Dad:

I could remember you best by your academic and literary excellence: authoring 29 books, 3 plays, countless articles and theological contributions over a lifetime of dedication and service, but I won't.

I could remember you best by your hard work ethic, always leading by example, and rarely if ever relaxing and taking a break. Your unceasing drive to provide and selfless ability to put the needs of family before yours, but I won't.

I could remember you best by your teaching ability- I've never seen it done better. You said once, when teaching "if you can't break things down and explain concepts in simple terms-you don't know your material well enough!" I could remember the great teacher the best, but I won't.

I could remember you best by your antics of which there are many: Your ability to mistakenly consume nonedible items rose to a near legendary status. This includes nearly all the parts of ANY fruit, including the seeds and rind, the paper fortune inside fortune cookies for over a decade before someone eventually stopped you. Your perfect imitations of various despots throughout history made us laugh and regard your acting abilities with awe. These gave us great moments of laughter and love for you. I could remember your humor the best, but I won't.

I could remember you best as a great crusader and reformer in the catholic church for whatever seemed to need improvement: your devotion to a married priesthood, optional celibacy, and voice for those affected by abuse became one of your greatest passions. You helped countless people with your service





and gave a voice to the voiceless. I could remember you best by your dedication to fixing what was broken in this world, but I won't.


I could remember you best by your deep love for mom, it was always there. It was our rock and our north star. It served as a supreme framework for our lives as your children. You left a legacy on how to love a woman and never stop. Your love for her was unyielding, indisputable, including your whole married life to your last day. I could remember you best by this dad, and this is a very high thing, but I will not.

Dad, I am amazed that you were able to always be there for all our milestones, our games, our birth-days, and concerts. You devotedly dropped it all to put us first. You always jumped into action when your family needed you and rescued us at pivotal moments when a crisis arose. I'll miss our talks in your office, always praising in public but softly correcting in private. I'll miss our long bike rides together, laughter at the dinner table, and family movie nights.

As a man that has spent his whole life reading and sharing the bible with others, I once asked him "Dad, what is your favorite part of the bible?" He responded without hesitation: "The Parable of the Prodigal Son". As I became an adult, and a prodigal son myself, I realized that he gave us the best example of what it means to love unconditionally.

No matter how far we went astray, no matter how off the path we went, you had the most forgiving and loving heart that forgot the bad and rejoiced with the good. It did not matter what WE DID, it mattered who YOU WERE: a godly example for all of us. This reflection of our heavenly father is how I remember you best. This is who he was first, this is how he lived, and this is how he was until his last day. Your example is alive with all of us! It will not perish!

Thank you for everything dad- but thank you for your unconditional love the most. We look forward to seeing you again and hearing you say "Welcome home, I love you, let's celebrate"!

Tribute to Anthony T. Padovano to Conscience Magazine by Linda Pinto

To meet Anthony T. Padovano is to be touched by the grace of God.

Whether as priest, pastor, professor, international lecturer, author (29 books, 3 plays translated into nine languages), energetic church reformer or just as a person, he touched your life in such a way that you were a better human being. He passed into eternity on June 22, 2024.

Essentially, his life was driven by three things: faith, family and the future.

Anthony was quintessentially catholic to his core. Born in Harrison, N.J., at a time when you identified by your Roman Catholic parish rather than your street address, it was clear early on that he possessed a towering intellect and an insatiable curiosity. These traits were rivaled only by a spontaneous, unpredictable but spot-on sense of humor. These attributes never wavered.

Excelling in school, he had hoped to either become a journalist or join the navy "to see the world". At fourteen, he encountered an intense call to priesthood and ministry. The rest is history. He entered Darlington Seminary and was ultimately sent to Gregorian University in Rome for further study on the cusp of Vatican II. He obtained his doctorate in theology.

In 1962, he returned to the U.S. and became a seminary professor of systematic theology. He distinguished himself by empowering and enabling seminarians to think for themselves rather than be boxed in by rigid dogmatic axioms. His courses always relied on contemporary media (literature, movies, plays, etc.) to illustrate fundamental theological principles. While retaining his seminary position, he was part of the founding faculty of Ramapo College, which grew into a four-year New Jersey State accredited institution. He served as a distinguished professor of literature and philosophy, and consequently Chair of the America Literature and International Studies until 2018.

He also became a visiting professor at over twenty-five American colleges and universities. It was during this time that he faced his greatest blessing and challenge. He soon realized he was in love with Theresa Lackamp, a religious Sister of Charity of Leavenworth, Kansas, attending one of his courses. His connection to her was as intense as his call to priesthood. They both realized their call to marriage was sacred and holy. There was only one course of action to take and be true to the spirit of Vatican II and the Spirit moving in our world. As the Vatican ignored their own Papal Biblical Commission finding no contradiction between priesthood and marriage, they married.

Together they shared their world with Mark, Andrew, Paul and Rosemarie and eventually five grand-children. Despite his intense schedule, family was the focus and core of his being. No matter what was being served, mealtime was sacred. It was the altar to test ideas, opinions and enlightened ways of thinking. He always found time to be present to the family during all their milestones, athletic games, concerts and birthdays. Family became the epicenter of his spiritual community.

He loved the church while also knowing that it needed to be changed. With his relentless (almost stubborn) optimism, he constantly watched for opportunities to reform and renew the priesthood, especially applying the principles of Vatican II.



In 1974, he helped establish CORPUS, the National Association for a Married Priesthood. CORPUS became a home for the over 35,000 canonical priests who chose love over law; a catholic marriage over a celibate commitment; family over isolation. His keynote presentation at the first national gathering in 1987 touched and transformed those who had been dismissed, discarded and disgraced by the official hierarchy. He served as President and then Ambassador for over 30 years traveling the globe to proclaim that marriage and ministry are compatible.

In 1986, he was approached by a local minister, Anne Hess, of the United Church of Christ. She was sensitive to the unmet needs of almost half of her parish who were catholic. He used this opportunity to develop a groundbreaking adventure in ecumenical ministry. The Inclusive Community was established as a place where people were welcomed and celebrated. Worship and ritual were designed to gather, celebrate and respect all denominations. He sought after and won recognition as a Roman Catholic priest in the UCC system. He invited other married priests to become involved as another opportunity to exercise their priesthood.

After attending the Parliament of World Religions, he proposed a spiritual center be established at Ramapo College. It would be modeled after the United Nations Meditation Room and be open to all students, faculty and visitors as a place for tranquility and reflection. It is known as the Padovano Peace Pavilion. He noted: "The essence of the spiritual is to encounter God in whatever transcendent reality one is seeking."

Always a church reformer, Anthony realized that almost all challenging issues facing the hierarchy (married priesthood, female ordination, LGBTQIA rights (especially marriage), reproductive choice, etc.) were rooted in a common thread. He became the ultimate champion of conscience as the arbiter of personal decision making.

In 1993, the fledgling Catholic Organizations for Renewal was formed. This was a consortium of over 22 catholic reform groups advocating for a more inclusive church in line with Vatican II. Catholics for Choice, a national group advocating reproductive choice including abortion, requested membership. He was present when they were denied entry into the room for discussion on the basis that the organization was not catholic. Some members were still holding onto the hope that they could enter into dialogue with bishops and achieve their goals. After an intensive exchange, he called for a break. During that time, he penned a seven-point treatise of what it was to be authentically catholic. When the vote was held, Catholics for Choice was accepted around the table.

Anthony continued to support and contribute to CFC as a board member and cherished contributor to Conscience, the journal of CFC. One of his articles entitled *A Personal Perspective: A Theologian on Humanae Vitae*, presented a theologically sound, pastoral approach to issues around birth control and freed individuals from the misconception of its infallibility. His contribution to the video *The Secret History of Sex, Choice and Catholics* further explored sound catholic theology and challenged barriers to a healthy expression of being human. He authored a book entitled *Life Choices* which examined the complexity of the issue.

His life's work meant nothing to him if it didn't lead to love. His celebration of life closed with his favorite hymn....*All I Ask of You is Forever to Remember Me as Loving You*.


To have known Anthony is to have been touched by the grace and love of God. And, we are better human beings because of it.





The Worth of a Woman

CORPUS is always grateful to our members for their feedback. Recently, a number of comments have mentioned that the pages of CORPUS REPORTS seem to focus more on women than on the issue of married priesthood. Their integral interconnection is never more evident than in our statement at the Forum on Women (July 2015).

CORPUS began in 1974 when priests, who had fallen in love, wanted to remain in active institutional service, but only if their wives were accepted and their marriages celebrated. Our history reflects a commitment to the co-equal status of women in the church and in society and their worth as co-equally reflecting the face of God.

It is telling, indeed, that if an ordained priest in active ministry falls in love and cannot come to terms with the church's policy of mandatory celibacy, he is free to pursue the relationship (affair) as long as it is quiet and discrete. What does this say about the worth of a woman?


If a priest falls in love and this relationship (affair) is blessed with children, a priest is free to continue in active institutional ministry as long as news of the affair is kept quiet. Women and children are often paid to promise silence using church funds. What does this say about the worth of a woman?

If a priest from another denomination requests to be recognized as a Roman Catholic priest, he is welcomed and celebrated along with his wife and family, as long as he signs an affidavit that he will not remarry if his wife dies. What does this say about the worth of a woman?

But if a man, born and raised catholic, becomes ordained and then falls in love, a calling we believe is also from God, he is forced to leave active ministry; required to move more than 40 miles away from his last parish; forbidden to participate in any parish ministries, including lector or Eucharistic minister and is frequently not granted permission to marry in a Roman Catholic Church.

These men of CORPUS have made the choice to cherish women as co-equal partners in love and life.

CORPUS stands as a witness to the worth and wonder of women's presence in our lives, our marriages, our families, our church, and our world.

CORPUS REPORTS

CORPUS was given birth 50 years ago in December of 1974 and, having profoundly impacted the lives of thousands in the United States and throughout the world, will pass into the pages of history this December, 2024. At our inception, we were determined to be the drop of water that would become a flood that would open the hearts and minds of the leaders of the institutional Church to the wisdom of an all-inclusive priesthood. We looked those leaders in the eye and we didn't blink. But they were unmoved. However, hope never dies and we did, in fact, enable thousands of married priests to reclaim the ministry which they ultimately received from Christ, the Eternal High Priest.

Because CORPUS has been committed to an inclusive priesthood of married and single men and women, it has been a gift to untold numbers of people during these many years. Providentially, during this beautiful season of Advent/Christmas when we celebrate God's unbelievable gift of a Savior, our organization will make a number of financial gifts to worthy organizations.

Our By Laws state the following: "In the event of liquidation or dissolution of CORPUS, the assets remaining after all debts have been satisfied are to be conveyed to a non-profit association qualified under Section 501 (c) (3) of the Internal Revenue Code of the United States, to be used for the purposes, as nearly as practicable, which are analogous to those for which the movement was created."

During a meeting in December, the Board surveyed numerous national and local organizations to determine where our assets would have the greatest impact. Among the many criteria discussed, the most significant were determined to be reform, ministry and service. Based upon our discussion, we decided to fund seven local organizations and five national organizations.

Local Groups to be gifted \$2,000 each: Holy Family Inclusive Catholic Community, Mary Magdala Community, Benincasa Community, Living Beatitudes Community, Living Water Inclusive Catholic Community, Leaven, Dignity Boston.

National Groups to be gifted 20% of our remaining assets: FutureChurch, Dignity USA, Roman Catholic Womenpriests-USA, Federation of Christian Ministries, Women's Ordination Conference.

We are both happy and grateful that, with these gifts, our ministry will live on and many of God's people will be blessed. Perhaps, two quotes will encapsulate our thoughts at this time of closure. The first is by Etienne de Grellet, Quaker missionary: "I shall pass this way but once; any good that I can do or any kindness I can show to any human being; let me do it now. Let me not defer nor neglect it, for I shall not pass this way again." And the second is from 2 Timothy, 4:7: "I have fought the good fight, I have finished the race, I have kept the faith." Amen.
